#### **NUS UK Board - Officer Trustees**

The NUS UK Board's principal function in exercising its powers, duties and functions shall be to serve the aims, objects and wishes of the National Conference, National Executive Council and committees in line with policy set out by those bodies.

The NUS UK Board is responsible for the management and administration of the National Union, this includes responsibility for the detailed internal budgets.

The NUS UK Board shall provide leadership and oversight of the long-term 'Campaigning and Influencing' plans and work of the NUS Group and ensure appropriate oversight of the delivery of the operating plans and KPIs in line with the overall aims and objectives.

### **NUS Services Board**

The NUS Services Board shall provide leadership and oversight of the long-term `Enterprise and Engagement' plans and work and ensure appropriate oversight of the delivery of the operating plans and KPIs that underpin the overall aims and objectives.
