## **Trustee Declaration of Interest Form: Guidance**

The following is a template for an annual Trustee's Declaration of Interests to be used if you have a Trustee Board irrespective of whether you are an incorporated body or an unincorporated association.

## How to Use:

You should ensure all of your Trustees complete and sign this <u>every</u> year and that the completed forms are saved securely with your governance documents.

Trustees should also be reminded that it is their responsibility to tell you if anything changes during the course of the year.

The information should be shared with the Chair of the Board so they are mindful of any conflicts of interest that might arise during meetings, although it is the responsibility of the individual trustee to ensure any conflicts they have are noted.

Top Tip: To help with administration you may want to use free, online form software to collate the data (such as Google Forms).

## **Declaration of Interests Form template:**

Trustees of the organisation are required to complete this form on an annual basis to advise of their interests.

The information in this form is used to update the register of interests and to assess possible or actual conflicts of interest that may arise in accordance with our conflicts of interest policy. The completion of this form does not remove the need for Trustees to declare interests to the clerk/company secretary/ Chief Executive/ General Manager/ Union Director/ Chair of the Board as and when they arise.
