# **Employment versus Employability:**

It can often be easier to make someone employable than find them a job which uses those skills.



## **Workshop Aims**

- Explore the results of the 2014 NUS Survey on International Students' Perceptions of Employment and Entrepreneurship
- Understand Tier 5 and how international students can use this route to gain work experience
- Share experiences and discussion



#### About the research

- NUS undertook a survey of international students' experiences of employment and Entrepreneurship, first in 2012 and again in 2014.
- The first research was undertaken in the aftermath of the Tier 1 Post Study Work visa closing in 2012 and a 10 per cent drop in international student numbers between 2010 and 2012. The second research was undertaken ahead of the All Party Parliamentary Group on Migration's inquiry into post-study work for international students.
- The 2014 research had 1599 valid responses.



## Who answered the survey?

- The highest proportions of respondents were from China (17 per cent), India (13 per cent) and USA (13 per cent)
- The majority of respondents (31 per cent) were studying in institutions in London, while 15 per cent were studying in Yorkshire and the Humber. 8 per cent were studying in Scotland, 4 per cent in Wales and less than 1 per cent in Northern Ireland
- The most common area of study was business and administrative studies (22 per cent), followed by creative courses (13 per cent).
- The most common level of study was Postgraduate Taught (41 per cent), followed by undergraduate (37 per cent), and postgraduate research (15 per cent). Less than 4 per cent studied at FE level.

#### Incentives and Intentions

- Similar to 2012, Three of the top five reasons international students come to the UK to study were based around finding future employment
- There has been a significant drop in the number of international students seeking to gain work experience in the UK but not to stay permanently.
  In 2012 72 per cent wanted to stay between 1 and 2 years, in 2014 that dropped to 49 per cent. The number of students seeking to work in the UK permanently rose slightly from 17 per cent to 22 per cent.
- 70 per cent of international students want to work while studying reinforcing the potential to gain employment skills as a reason to the study in the UK
- Unfortunately 65 per cent are either not at all confident or only somewhat confident they will be able to find legal employment after they study. Only 4 per cent were extremely confident they would find work.

## Volunteering (from 2012 Survey)

- Only a minority of international students (36 per cent) have accessed volunteering opportunities
- Some 80 per cent of international students find their volunteering opportunities through their students' union or institution, only 37 per cent access volunteering opportunities through their local communities




### Meeting Tier 2 requirements

- 32 per cent of students felt they would make less than £20,000 in their first graduate job. Less than the required amount for Tier 2
- 42 per cent of students felt they would find a job within 4 months of graduation.
- 51 per cent of students did not think it would be easy to find work in the UK that is relevant to my chosen career.
- 24 per cent did not feel they were aware and understood all the regulations to work after study.



## Understanding the options



I am not aware of this option for post-study work



#### Entrepreneurs

- 42 per cent of students were interested in starting their own business. Only 14 per cent would choose the UK to start their business.
- While 20 per cent of those who are keen to start a business have considered Tier 1 (Graduate Entrepreneur), only 2 per cent have applied.
- 20 per cent of students want to meet and network with others in their industry.



#### Overall

- 32 per cent of students think the UK process for post study work is worse than other counties. 18 per cent think it is better.
- Thinking about the work experience and employment opportunities available to them, per cent would not advice a friend or relative to study in the UK.
