Plan of Work 2018-19





1. The purpose of the Plan of Work

This Plan of Work will outline the priorities for the international relations team over the coming year as well as outlining progress that has been made in implementing the "International Relations Long Term Strategy" agreed by the NUS Trustee Board in 2015. It will also be mindful of some of the long term aims expressed in the NUS 100 strategic framework as well as NUSUK's priorities for 2018/19.

- The Black Attainment Gap linked to Brilliant Student Leadership
- A membership satisfaction rating of 80%
- Promoting the benefits of TOTUM to our membership
- Addressing the issue of culture within NUSUK
- Developing ideas for the future

The majority of our work will fall into the area of policy delivery, seeking to influence the Brexit debate and influencing the policies and approach of the Bologna Follow Up Groups (BFUG)¹, raising the issue of the Black Attainment Gap at an international level and keeping an eye on future developments as UKHE seeks to enhance its global reach.

2. Vision, Rationale and Values

Students, student officers and students' union staff will be engaged in activities that will achieve our objectives in these areas as well enhancing their own personal development and cultural understanding. Students and student organisations will be seen as part of the solution to global challenges and their commitment to positive change and collaboration will stay with them throughout their lives

3. How we approach International Relations

NUSUK is a confederation of students' unions in the United Kingdom. We exist to act on behalf of those students' unions, carrying out the collective influencing and development work at an international level that it would be difficult for any single students' union to do on its own. NUSUK's mission is to:

- Promote, defend and extend the rights of students
- Develop and champion strong students' unions

The long term international relations plan was agreed to ensure that the student voice was heard at an international level. Higher Education is increasingly becoming globalised, despite the impact of Brexit almost all UK universities have, as part of their core mission, international reputation and standing as well as international partnerships. As these partnerships, whether that be through joint research programmes or trans national education develop, where and how the student voice should be heard changes and we need to ensure that we can effectively make the case for student representation to be an integral part of new educational initiatives. In a post-Brexit UK these initiatives could well be linked to trade negotiations as the UK seeks to forge a new relationship with countries beyond the EU.

International relations work has been priortised by developing the six work streams and by having a clear rationale behind which organiations we are engaged with. Our most important partners are the European Students' Union, the Commonwealth Students' Association and the Association of College Unions International. Internally our key partner is the Sustainability Team who have been successful in developing international projects and other global partnerships that fully align with our values and objectives.

Overall responsibility for our international relations work lies with the President, with the Vice President Higher Education being responsible for our work with the European Students' Union which ultimately has an HE focus. The work round global solidarity tends to be led by the Vice President for Society and Citizenship. From July 2019 it is clear where, if at all, work on society and citizenship will sit.

We will keep our membership and other NUSUK colleagues informed of what we are doing through Workspace which is a "Facebook Style" online platform that allows us to

5 Plan Links to NUS 100

NUS 100 is NUSUK's strategic plan that will take the organisation up to its centenary in 2022.

5.1: Shaping Education and Empowering Individuals

Through our international relations work we will contribute to the following NUS100 themes under the broad heading of shaping education and empowering individuals.

- Theme 1: Everyone can access and excel in Post 16 education by working with partners to eradicate attainment gaps.
- Theme 2: The learner voice creates change in education by demonstrating the value and impact of learner voice and student engagement across further and higher education.
- Theme 4: Students should be confident to engage in civic life by building civic engagement through political education.

We will engage in work streams that will seek to:

5.1.1: Influence Higher Education Policy at a European Level through co-operating through the European Students Union, in order to ensure that NUSUK policies form part of the policy portfolio of the European Students' Union who will seek to influence the EHEA on our behalf. Exchange good practices, ideas and learning. We will:

- Update the "ESU through NUS Eyes" guidance document (September 2018)
- Develop an up-to-date briefing on the Bologna Process following the Paris Ministerial in May 2018 (August 2018)



- Participate in Board Meeting 75 (November/December)
- Participate in Board Meeting 76 (April/May)
- Participate in European Students Convention 36 (October)
- Participate in European Students Convention 37 (March)
- Participate in Networking meetings that are preparing and developing our European policy approach
- Develop a transparent system for opening up ESC meetings and seminars to member students' unions
- Submit membership re-evaluation documents by October 2018

5.1.2: Investigate the possibility to host ESU Board Meeting 76 (May 2019) in partnership with VVS/FEF (Belgium). In order to provide a high-profile platform that expresses our commitment to European wide collaboration:

- Meet with VVS/FEF on a regular basis to plan the event
- Identify and secure sources of funding for the event and develop a compelling vision/pitch
- Liaise with and invite high profile speakers to parts of the event
- Liaise with the Events team over logistics for the event
- Hold regular planning meetings with VVS, FEF and ESU

Membership Satisfaction: More information about international learning opportunities and exchanges will be appreciated by member students' unions.

Future Thinking: Activities that strengthen the effectiveness and profile of the international student movement strengthen NUSUK. Developments in UK HE/FE over the next decade will require a strong internationalist reputation and our input on the role of the student voice.

5.2. Being an Outstanding Student Led Campaigns and Membership Organisation

Through our international relations work we will contribute to the following themes under the broad heading of being an outstanding student led campaigns and membership organisation.



- Theme 1: Supporting excellence in students' unions by developing a collaborative approach
- Theme 2: Developing a strong and influential collective voice
- Theme 4: Attracting and retaining outstanding people
- 5.2.1: To arrange for visits to conferences and study visits by international guests and provide support and guidance for students' unions and NUSUK colleagues attending international meetings. In order to provide opportunities for leaning and exchange of good practice at an international level and to capture that learning.
 - Arrange international speakers for conferences as requested
 - Promote relevant NUSUK conferences to international partners as appropriate
 - Agree an internal system for approving and reporting international engagement.

 - Co-ordinate study visits and exchanges as required
 - Maintain a database on international initiatives though the CRM
 - Inform members about international opportunities through workspace
 - Support delegates to ACUI Region VIII and ACUI National Conference (November 2018 and March 2019)
 - Develop an application system for students' union officers to access meetings of the European Students' Convention. (August 2018)
 - Facilitate international input into the Membership Services Conference
- 5.2.2: To share information and take part in capacity building partnerships. In order toshare our learning and experience with other national student organisations and provide colleagues with international engagement opportunities.
 - Highlight international engagement opportunities
 - Continue to support the development of USK Kosovo
 - Continue to promote the "Building Student Representation" toolkit with the Commonwealth Students' Association
 - Facilitate international input into liberation campaigns
 - Identify externally funded opportunities to work in partnership with other national students' unions
